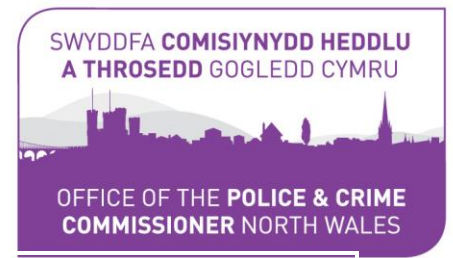


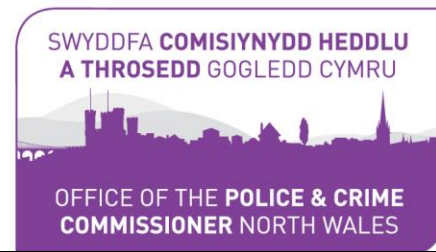

<p>Mae'r hysbysiad o benderfyniad yn cadarnhau bwriad y Comisiynydd Heddlu a Throsedd i ymestyn y cytundeb Dechrau Newydd o 31 Mawrth 2024 i 31 Ionawr 2024.</p> <p>Nod gwasanaeth Dechrau Newydd ydy ymgysylltu gyda throseddwr sy'n defnyddio sylweddau a'u cynorthwyo i leihau trosedd, gwella iechyd a chymdeithasu, ymgysylltu gyda chymorth amlasiantaethau a gwneud newidiadau cynaliadwy i'w ffordd o fyw.</p> <p>Mae dalfeydd, llysoedd, swyddfeydd prawf a charchardai'n cynnig cyfleoedd allweddol i nodi, hysbysu ac ymgysylltu troseddwr sy'n defnyddio sylweddau. These can be challenging environments to deliver treatment services within, especially when engaging with individuals who may be particularly anxious, mistrustful and vulnerable.</p> <p>This is to be achieved through the delivery of a service which encompasses the provision of:-</p> <ul style="list-style-type: none">• Tailored holistic support for those identified as voluntary service users• Appropriate tailored support to meet the requirements of Conditional Cautions (Drugs).• Provision of drug testing tailored therapeutic and wraparound support packages, and information provision as appropriate for the delivery of Drug Rehabilitation Requirement (DRR) and Alcohol Treatment Requirement (ATR) orders. <p>The Dechrau Newydd contract will conclude on the 30th September 2024.</p>

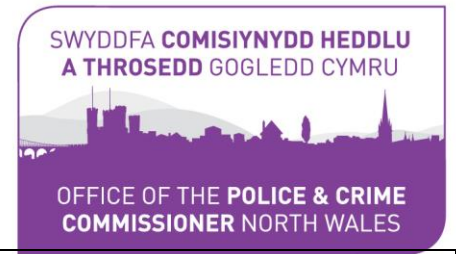
