Executive Summary: Proceeds of sale of unclaimed property in the possession of the police will be placed in a separate account called the Police Property Act Fund. The Police Property Act Fund ("the fund") is the responsibility of the Police and Crime Commissioner. It was decided by the previous authority, North Wales Police Authority that PACT, Police and Community Trust, will manage "the fund" on its behalf. The Police and Crime Commissioner in 2014 confirmed that decision. This decision notice confirms that the Police and Crime Commissioner further approves the continuation of the decision that PACT manages "the fund" based on the conditions below:-
