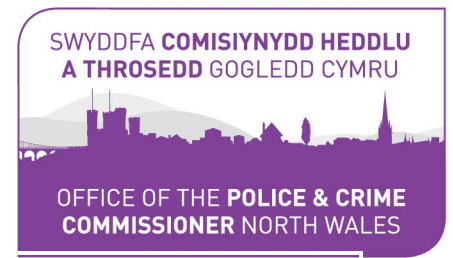


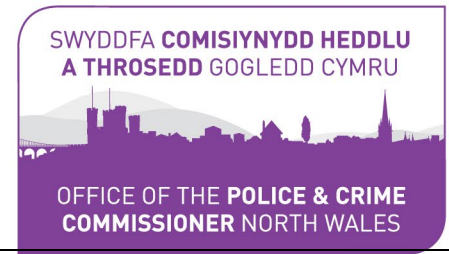

<p>Mae'r gwaith hwn wedi'i gomisiynu mewn ymateb uniongyrchol i'r gofynion a amlinellir gan y Swyddfa Gartref wrth roi grant bach i awdurdodau a gwasanaethau penodol ledled gogledd Cymru.</p> <p>Bydd y gwaith hwn yn ysbrydoli cyfeiriad rhaglenni gwaith y dyfodol ar gyfer Dyletswydd Trais Difrifol 2024-25.</p> <p>Rhaid i'r prosiect hwn ddod i ben erbyn 31 Mawrth 2025.</p> <p>Bydd y prosiect hwn yn cyflawni canlyniadau i 250 o bobl ifanc 11-18 oed yn Sir y Fflint sydd wedi'u heffeithio gan drais stryd drwy eu cysylltiad drwy lle maent yn byw ac yn astudio. Mae effaith y prosiect yn cael ei fesur drwy dull gwerthuso 'cynt a wedyn' sy'n dangos canlyniadau mewn pedwar maes allweddol sy'n cyfateb y canlyniadau a fwriadwyd.</p>	<p>This work has been commissioned in direct response to the requirements outlined by the Home Office in administering a small grant to specified authorities and services across north Wales.</p> <p>This work will inform the future direction of work programmes for the Serious Violence Duty in 2024-25.</p> <p>This project must conclude by 31 March 2025.</p> <p>This project will achieve outcomes for 250 young people aged 11-18 in Flintshire who are affected by street violence through their involvement or exposure via where they live and study. The impact of the project is measured through a comparative 'before and after' evaluation method which evidences outcomes in four key areas which match the intended outcomes.</p>
