<p>Yn dilyn llwyddiant y Gronfa Arloesi i Dyfu'r Comisiynydd yr Heddlu a Throsedd. Mae'r Comisiynydd wedi dyrannu £75,000 eto ar gyfer 24/25 i gefnogi prosiectau am un flwyddyn. Ffocws y cynlyn yw targedu prosiectau newydd ac arloesol i ategu blaenoriaethu'r cynllun Heddlu a Throsedd, a'i ymdriniaeth Gwasanaethau Heddlu Cymunedol (COPS) i wasanaethu pob cymuned ledled Gogledd Cymru.</p> <p>Mae croeso i geisiadau trwy gydol 2024-25.</p>	<p>Following the success of the Police and Crime Commissioner Innovate to Grow scheme. The Commissioner has allocated a further £75,000 for 24/25 to support projects for up to 1 year. The focus of the scheme is to target with new and innovative projects to compliment the police and crime plan priorities, and his Community Oriented Police Service (COPS) approach to serve all communities across North Wales.</p> <p>Applications are welcome throughout 2024-25.</p>
