Rhennir mwgwd derbynnydd hefo sefydliad a all ddarparu ffilm amser real o'r hofrennydd i'r ystafell reoli.</p> <p>Gellir hepgor gorchmynion sefydlog o ran yr angen i dendro cytundeb os ydy'r gofyn yn arbenigol ei natur. Gellir ond ei ddarparu'n rhesymol gan gyflenwr unigol. Mae'r Pennaeth Caffael o'r farn fod y nwyddau neu'r gwaith angenrheidiol yn nodwedd perchenogol neu arbennig. Nid yw'n bosibl neu'n ddymunol cael prisiau cystadleuol, oherwydd natur arbenigol y gofynion.</p>	<b>Executive Summary:</b> <p>North Wales Police have requested a waiver in the standing orders in relation to the procurement of a Helicopter Receiver Downlink Site.</p> <p>The agreement and service has been in place for several years. A receiver mask is shared with an organisation which can provide real time footage from the helicopter to the control room.</p> <p>Standing orders in relation to the requirement to tender contract may be waived if the requirement is specialist in nature and can only be reasonably provided by a single supplier. The Head of Procurement is of the opinion that the goods or services or works required are of a proprietary or special character for which it is not possible or desirable to obtain competitive prices, due to the specialist nature of the requirements.</p>
