The aim of the funding was to support sporting activities to keep children and young people occupied in a positive way, while also promoting teamwork, exercise, and a fun in an inclusive atmosphere for everyone throughout the summer holidays.</p> <p>Allocation of funding is attached to this decision notice.</p>
