Gellir hepgor gorchmynion sefydlog o ran yr angen i dendro cytundeb er mwyn caniatáu cytundeb tymor byr er mwyn osgoi aflonyddu cyflawni gwasanaeth plismona.	Executive Summary: North Wales Police have requested a waiver in the standing orders in relation to the procurement of a digital crime prevention tool for acquisitive neighbourhood crime for the public to use as an education tool. The service has already been developed for another UK Police Force and can be adapted to the needs of North Wales Police. As the product has already been developed, there is a saving in cost and time to procure this software direct. Standing orders in relation to the requirement to tender contract may be waived to allow a short-term contract to avoid a disruption in delivering a policing service.
