<p>Mae'r gwaith hwn wedi ei gomisiynu mewn gwerthusiad annibynnol er mwyn asesu effeithiolrwydd, effaith a gwerth am arian brosiectau trais difrifol wedi eu hariannu gan Bartneriaeth Diogelwch Cymunedol ar draws Gogledd Cymru.</p> <p>Bydd y gwaith hwn yn dylanwadu ar ddatblygu ffrydiau gwaith ar gyfer Y Ddyletswydd Trais Difrifol ym mlwyddyn ariannol 2024-25.</p> <p>Amcanion cyffredinol y gwerthusiad hwn ydy:</p> <ul style="list-style-type: none"> - Asesu i ba raddau mae prosiectau yn cyrraedd eu hamcanion ac yn cyfrannu tuag at leihau trais difrifol yng Ngogledd Cymru. - Gwerthuso cynllun y prosiect, prosesau rhoi ar waith a nabod meysydd ar gyfer gwella. - Dadansoddi effeithiolrwydd cost yr ymyrraethau o gymharu â'r canlyniadau. - Adnabod dysgu allweddol ac arferion gorau o'r prosiectau i roi gwybod am benderfyniadau comisiynu'r dyfodol. <p>Mae'r prosiect yn adeiladu ar y weledigaeth ar gyfer 'Gogledd Cymru heb drais.' Mae'r meysydd yn cynnwys gwaith ataliol, diogelu o fewn cyd-destun, caethwasiaeth fodern, VAWDASV a gwaharddiadau o'r ysgol.</p>	<p>This work has been commissioned to conduct an independent evaluation to assess the effectiveness, impact, and value for money of the serious violence intervention projects funded by the Community Safety Partnerships across North Wales.</p> <p>This work will directly influence the development of work streams for the Serious Violence Duty in the 2024-25 fiscal year.</p> <p>The overall objectives for this evaluation are:</p> <ul style="list-style-type: none"> - Assess the extent to which projects are meeting their stated objectives and contributing to the reduction of serious violence in north Wales. - Evaluate the project design, implementation processes, and identify areas for improvement. - Analyse the cost-effectiveness of the interventions compared to their outcomes. - Identify key learning and best practices from the projects to inform future commissioning decisions. <p>This project is building on the vision for a 'North Wales Without Violence.' Together with the overarching strategic objective: To work together with our communities to prevent and reduce serious violence in North Wales. Building upon the risk factors like ACEs and trauma with the main focus on primary prevention.</p> <p>The Serious Violence Strategy prioritises actions that target specific types of serious violence outlined within the document. These focus areas include preventative work, contextual safeguarding, modern slavery, VAWDASV and School Exclusions.</p>
