Executive Summary: North Wales Police have requested a waiver in the standing orders in relation to the continued procurement of the BT EISEC Circuit system. The connection is required for emergency calls to Police Headquarters and the Joint Communication Centre. There is no other provider for this on the market. Standing orders in relation to the requirement to tender contract may be waived if the requirement is specialist in nature and can only be reasonably provided by a single supplier.
