<p>Mae'r penderfyniad hwn yn cadarnhau bwriad Comisiynydd Heddlu a Throsedd i gyflawni rhaglen CARA (Rhybuddio a Cham-drin mewn Perthynas) Uned Lleihau Aildroseddu'r Heddlu Gogledd Cymru.</p> <p>Cyflawnir CARA fel rhaglen beilot gychwynnol. Oherwydd niferoedd atgyfeirio isel disgwyliedig yng Ngogledd Cymru, bydd yn cael ei hymgorffori fel rhan o fframwaith lleihau aildroseddu Heddlu Gogledd Cymru.</p> <p>Mae gan yr Uned Lleihau Aildroseddu fframwaith datrysiad tu allan i'r llys a wnaith hwyluso'r rhaglen CARA. Mae'r tîm, sy'n cynnwys 12 llywiwr, y dod â chyfoeth o wybodaeth a phrofiad i gyflawni ymyriadau holistaidd sydd hefo'r bwriad o ymdrin ag anghenion achosion trosedd y rhai hynny a gyfeirir ar gyfer datrysiad tu all i'r llys.</p> <p>Cynhelir gwerthusiad llawn yn y dyfodol er mwyn adolygu gweithredu'r gwasanaeth.</p>	<p>This decision notice confirms the Police and Crime Commissioner's intention to deliver the CARA (Cautioning and Relationship Abuse) programme via North Wales Police's Reducing Reoffending Unit.</p> <p>CARA will be delivered as an initial pilot programme and due to the anticipated low referral numbers in North Wales will be incorporated as part of the reducing reoffending framework within North Wales Police.</p> <p>The Reducing Reoffending Unit has an existing out of court disposal framework which will accommodate the CARA programme and the team, made up of 12 navigators, bring a wealth of knowledge and experience to the delivery of holistic interventions that look to address the criminogenic needs of those referred for an out of court disposal.</p> <p>A full evaluation will be undertaken in the future to review the implementation of the service.</p>

<p>Ariannol – Bydd ffi cludo sef £15,000 wedi'i ddyrannu i Ymddiriedolaeth Hampton ar gyfer costau danfon parhaus gan gynnwys ffi trwydded, defnyddio deunyddiau CARA a sicrwydd ansawdd.</p> <p>Bydd cyfanswm sef £10,000 yn cael ei ddyrannu i Uned Atgyfeirio Heddlu Gogledd Cymru ar gyfer gweinyddu a recriwtio.</p>	<p>Financial – A mobilisation fee of £15,000 will be allocated to the Hampton Trust for ongoing delivery costs including license fee, use of CARA materials and quality assurance.</p> <p>A total of £10,000 will be allocated to the Diversion Unit for administration and recruitment.</p> <p>A further £2,000 will be allocated to the Diversion Unit for each cohort with an average of ten offenders per cohort.</p>
