Cytunodd y pedwar comisiynydd i roi nawdd Platinwm am flwyddyn yn unig, gyda'r bwriad o gael penderfyniad strategol ehangach yn ystod yr misoedd nesaf yn ymwneud â chyfraniad CHTH i weithgaredd gwrrth-hiliaeth gyda'r bwriad o ystyried dosrannu nawdd mewn blynnyddoedd i ddod.	Executive Summary: At the Policing in Wales meeting held on 12 September 2024, the four Welsh Police and Crime Commissioners discussed whether to provide sponsorship to Race Council Cymru in 2024/25. All four Commissioners agreed to provide Platinum sponsorship for one year only, and intend to have a broader strategic discussion in the coming months around OPCC's contributions to anti-racism activity with a view to considering the apportionment of funding in future years.


