Mae HGC yn dymuno parhau hefo hyn gan y gall tendro a newid cyflenwyr fod yn drafferthus gan fod byrddau dyrchafu ar y gorwel.</p> <p>Rhoddwyd sicrwydd i lwyddiant y prosiect.</p> <p>Caniateir hepgor y gorchmynion sefydlog er mwyn caniatáu rhoi cytundeb tymor byr, wrth ddisgwyl proses dendro ffurfiol ac osgoi ymyrraeth wrth gyflawni gwasanaeth plismona.</p>	<p>North Wales Police have requested a waiver in the standing orders in relation to the procurement of a service to support officers seeking promotion to leadership positions.</p> <p>The service is currently provided by a supplier and NWP wish to continue with this as tendering and changing suppliers could be disruptive as promotion boards are imminent.</p> <p>Assurance has been provided to the success of the project.</p> <p>It is permissible to waive the standing orders to temporarily to allow a short-term contract to be awarded pending a formal tender process and to avoid a disruption in delivering a policing service.</p>
