Crynodeb Gweithredol: <p>Mae'r penderfyniad hwn mewn ymateb i gyflwyno strategaeth ddrafft a chynnig cyllid gan Bartneriaeth Arloesedd Cymru am gymorth parhau i Gydweithrediad Academaidd Heddluoedd Cymru Gyfan.</p> <p>Ym mis Mehefin 2022, yng nghyfarfod Pwyllgor Plismona yng Nghymru, gwnaeth pedwar CHTh a heddlu Cymru gytuno cyfrannu £5k yr un dros 2 flynedd ar gyfer cydweithrediad academaidd er mwyn cynorthwyo plismona dystiolaeth. Sefydlwyd Cydweithrediad ac fe benodwyd Grŵp Llywio er mwyn goruchwyllo cyllid ar gyfer meysydd ymchwil perthnasol – £80k y flwyddyn.</p> <p>Mae'r Cydweithrediad wedi ariannu 8 prosiect ymchwil – pump ar raddfa fach a 3 hirach.</p> <p>Mae'r Strategaeth ddrafft yn cynnig 4 blynedd o ymrwymiad. Mae hynny dros 3 blwyddyn academaidd, gan gynnwys arweinydd yn ei dro yn cymeradwyo prosiectau ymchwil a chyfnod gwerthuso ar y diwedd. Mae felly'n 4 blynedd i gyd. Cynigiwyd dau opsiwn ariannu o fewn dogfen y strategaeth.</p>	Executive Summary: <p>This decision is in response to the submission of a draft strategy and funding proposal by the Wales Innovation Partnership for continued support for the All-Wales Police Academic Collaboration (AWPCA).</p> <p>In June 22, at a meeting of the Policing in Wales Committee, the four Welsh PCCs and police forces agreed to contribute £5k each over 2 years to academic collaboration to support evidence-led policing. AWPAC was set up with a Steering Group appointed to oversee funding for relevant research areas – £80k over 2 years.</p> <p>AWPAC has funded 8 research projects – five small-scale and 3 longer research projects.</p> <p>The draft AWPAC 2024-28 Strategy proposes a 4-year commitment, over 3 academic years, including a lead in time to approve research projects and an evaluation period at the end, hence 4 years in total. Two funding options were proposed within the strategy document.</p>

<p>Y Cynllun Heddlu a Throsedd: Mae ymchwil academaidd yn hwyluso plismona tystiolaeth er mwyn cynorthwyo a gwella gwybodaeth a dealltwriaeth mewn meysydd allweddol a gwerthuso prosiectau peilot. O'r 8 prosiect ymchwil a ariannwyd yn 2 flynedd gyntaf y Cydweithrediad, roedd 5 yn canolbwytio ar VAWDASV, 1 ar rannu data, 1 ar wirfoddoli ac 1 ar ymddiriedaeth a hyder y cyhoedd. Mae'r rhain yn gydnaws hefo'r Cynllun Heddlu a Throsedd er mwyn cynorthwyo dioddefwyr a chymunedau a darparu presenoldeb plismona cymdogaethau lleol. Y bwriad yn y Strategaeth newydd ydy cyd-fynd hefo prosiectau gan gynorthwyo ymddiriedaeth a hyder. Mewn egwyddor, dylai fod yn gydnaws hefo'r mwyaf o flaenoriaethau cynllun heddlu a throsedd ar draws 4 SCHTh/heddlu Cymru.</p> <p>Y Gymraeg: Mae 'cynnyrch' ymchwil wedi cael eu creu'n bennaf yn Saesneg hefo rhai cyflwyniadau dwyieithog. Mae'r 'cynnyrch' hyn at ddefnydd mewnol. Cânt eu defnyddio er mwyn ysbrydoli strategaeth newydd a/neu arferion ymarferol. Nid oes bwriad eu rhannu'n gyhoeddus.</p> <p>AD: Amherthnasol</p> <p>Cydraddoldeb: Gosodir cylch gorchwyl ar gyfer bob prosiect er mwyn sicrhau y gosodir safonau moesegol i brosiectau ymchwil.</p>	<p>Police and Crime Plan: Academic research facilitates evidence-based policing to support and improve knowledge and understanding in key areas and evaluate pilot projects. Of the 8 research projects funded in the initial 2-years of AWPAC, 5 focussed on VAWDASV, 1 on data sharing, 1 on volunteering and 1 on public trust and confidence. These align with the Police and Crime Plan to support victims and communities and provide a local neighbourhood policing presence. The stated intention in the new Strategy is to align with projects supporting trust and confidence, which should, in principle, fit with most police and crime plan priorities across the 4 Welsh OPCCs/forces.</p> <p>Welsh language: Research 'products' have primarily been produced in English with some bi-lingual presentations. These 'products' are for internal use. They will be used to inform new strategy and/or working practices rather and are not intended for public dissemination.</p> <p>HR: N/A</p> <p>Equality: Terms of Reference are in place for each project to ensure ethical standards are applied to research projects.</p>
