<p>Mae'r gwaith hwn wedi ei gomisiynu mewn ymateb uniongyrchol i'r disgwyliadau sydd wedi eu hamlinellu gan y Swyddfa Gartref yn gweinyddu grant bach i awdurdodau a gwasanaethau penodol ar draws gogledd Cymru.</p> <p>Bydd y gwaith hwn yn dylanwadu ar ddatblygu ffrydiau gwaith ar gyfer Y Ddyletswydd Trais Difrifol ym mlwyddyn ariannol 2024-25. Datganolwyd awdurdod gwneud penderfyniadau yn strategol i Bartneriaethau Diogelwch Cymunedol (CSPs) yn ystod cyfarfod comisiynu ar 21 Mawrth 2024. Mae'r dull hwn yn grymuso CSP i deilwra cefnogaeth i'w anghenion penodol o fewn y strategaeth yn gyffredinol. Mae hyn yn meithrin teimlad o gyfrifoldeb ar y cyd ymysg awdurdodau neilltuol ac asiantaethau, yn hyrwyddo gweithredu'r strategaeth yn effeithiol tymor hir.</p> <p>Mae'r prosiect yn adeiladau ar y weledigaeth ar gyfer 'Gogledd Cymru heb drais.' Gydag amcan strategol cyffredin: Cydweithio hefo'n cymunedau er mwyn atal a lleihau trais difrifol yng Ngogledd Cymru. Gan adeiladu ar y ffactorau risg fel ACE a thrawma gyda'r prif ffocws ar ymyrraeth gynnar.</p> <p>Mae Strategaeth Trais Difrifol yn blaenoriaethu gweithrediadau sy'n targedu mathau penodol o drais difrifol wedi ei amlygu o fewn y ddogfen. Mae'r meysydd yn cynnwys gwaith ataliol, diogelu o fewn cyd-destun, caethwasiaeth fodern, VAWDASV a gwaharddiadau o'r ysgol.</p> <p>Bydd effeithiolrwydd y gwaith yn cael ei asesu drwy werthusiad sy'n edrych ar sut mae ymyrraethau sydd wedi cael eu rhoi ar waith yn ateb anghenion a nodwyd.</p>	<p>This work has been commissioned in direct response to the requirements outlined by the Home Office in administering a small grant to specified authorities and services across north Wales.</p> <p>This work will directly influence the development of work streams for the Serious Violence Duty in the 2024-25 fiscal year. Decision making authority was strategically devolved to individual Community Safety Partnerships(CSPs) during a dedicated commissioning meeting held on 21 March 2024. This approach empowers CSPs to tailor support to their specific needs within the overall strategy. This fosters a sense of shared responsibility among all designated authorities and agencies, promoting effective and long-term implementation of the strategy.</p> <p>This project is building on the vision for a 'North Wales Without Violence.' Together with the overarching strategic objective: To work together with our communities to prevent and reduce serious violence in North Wales. Building upon the risk factors like ACEs and trauma with the focus on primary prevention.</p> <p>The Serious Violence Strategy prioritises actions that target specific types of serious violence outlined within the document. These focus areas include preventative work, contextual safeguarding, modern slavery, VAWDASV and School Exclusions.</p> <p>The effectiveness of this work will be assessed through an evaluation that examines how implemented interventions address identified needs.</p>

Funds totalling £7,200 reallocated to Ynys Mon for their reserve project which is 'Support through Sport'.</p> <p>OPCC were also notified by Wrexham CSP on 13/09/2024 that the FABI Project is unable to continue. Following a CSP meeting they have accepted the recommendations to reallocate the FABI funding to the following existing projects: Disruption Service (£6340) and Don't Steal My Future (£2031).</p>
