## **Gweinidog Partneriaeth Gymdeithasol a CHTh Gogledd Cymru yn ymweld â Bangor i weld sut mae mynd i'r afael a cham-drin geiriol yn y sector manwerthu**

Ar 27 Awst, ymwelodd Gweinidog Partneriaeth Gymdeithasol Llywodraeth Cymru, Jack Sargeant AS, ac Andy Dunbobbin, Comisiynydd Heddlu a Throedd Gogledd Cymru â siop Boots ar y Stryd Fawr ym Mangor er mwyn dysgu mwy am y mesurau sydd mewn lle i sicrhau bod staff manwerthu yn cael eu diogelu rhag cam-drin geiriol a chorfforol. Digwyddodd yr ymweliad flwyddyn ar ôl lansio Cynllun Gweithredu Manwerthu Llywodraeth Cymru sy'n cynnwys camau i fynd i'r afael a cham-drin gweithwyr mewn siopau.

Yn ôl y ffigyrâu diweddaraf o [Arolwg Troseddau BRC 2024](#), bu dros 475,000 o ddigwyddiadau treisgar yn erbyn gweithwyr ym maes manwerthu yn ystod 2022-23 ar draws y DU. Golyga hyn 1,300 digwyddiad y dydd, a oedd yn gynnydd o fwy na 850 y dydd yn 2021-22 a bron i dair gwaith yn fwy na'r ffigwr cyn y pandemig o 450 yn ystod 2019-2020. Dim ond 36% o ddigwyddiadau o drais a cham-drin a gafodd eu riportio i'r heddlu gan fanwerthwyr.

Mae Boots wedi bod yng nghanolfan siopa Bangor am ddegawdau, wrth ymyl canolfannau siopa Menai a Deiniol. Mae Bangor wedi gweld newid mawr yn ystod y blynnyddoedd diwethaf yn sgil newid mewn arferion siopa a achoswyd gan y pandemig. Serch hynny mae ymroddiad cadarn ymysg y gymuned leol, perchnogion busnes ac awdurdodau lleol i weld y ganolfan siopa yn adfywio, ac iddi fod yn le dymunol i siopwyr a staff manwerthu fel ei gilydd. ## **Minister for Social Partnership and North Wales PCC visit Bangor to see how physical and verbal abuse in the retail sector is being tackled**

On 27 August, Minister for Social Partnership in the Welsh Government, Jack Sargeant MS, and North Wales Police and Crime Commissioner Andy Dunbobbin visited Boots on Bangor High Street to learn more about measures underway to ensure retail staff are protected from verbal and physical abuse. The visit took place a year following the launch of the Welsh Government's Retail Action Plan which includes steps to tackle abuse of shopworkers.

According to the latest figures from the [BRC's Crime Survey 2024](#), over 475,000 incidents of violence and abuse were made against retail workers during 2022-23 across the UK. This amounted to 1,300 incidents a day, which was an increase from more than 850 a day in 2021-22 and is approaching three times the pre-pandemic figure of 450 during 2019-2020. Only 36% of incidents of violence and abuse were reported to police by retailers.

Boots has been a mainstay in Bangor's shopping centre for decades and lies adjacent to the main Menai and Deiniol shopping centres. While Bangor's main city-centre retail core has undergone change in recent years, exacerbated by the change in shopping habits caused by the pandemic, there remains a strong commitment in the local community, business owners and among local authorities to see Bangor's shopping area regenerate, and for it to be the most pleasant environment possible for shoppers and retail staff alike.
